1. **SWEEPSTAKES PERIOD:** The Sweepstakes will begin 1 June 16 at 12:00:00 PM Central Time (CT) and will end 30 Jun 16 at 11:59:59 PM CT (the "Sweepstakes Period"). The Program Manager's computer, or that of his/her designee, will mark the start and end times and dates for the Sweepstakes. The Program Manager is Sally Truhitte, Air Force Services Activity (AFSVA), Directorate of Operations (SVO), Food & Beverage Division (SVOF), Business Operations Manager, Building 1, 2261 Hughes Avenue, Suite 156, Joint Base San Antonio-Lackland, Texas.

2. **SWEEPSTAKES DRAWING DATE AND NUMBER OF WINNERS:** Weekly drawings for all Sweepstakes prizes will be conducted on the following dates during the month of June 2016: 10 Jun, 17 Jun, 24 Jun, and 30 Jun ("Sweepstakes Drawing Dates"). Two (2) new applicants will be randomly selected from all applications received to win a \$500 Best Buy e-gift card. A total of eight (8) winners will each receive a grand prize of a \$500 Best Buy e-gift card.

3. **ELIGIBILITY:** The Sweepstakes is open to all new Air Force Club members, 18 years and older, who apply for membership during the Sweepstakes Period. (See AFI 34-272, Air Force Club Program, paragraph 1.6.1., Active Membership, for Club membership eligibility criteria.)

4. **THOSE INELIGIBLE:** The following AFSVA employees are not eligible to enter or win the Sweepstakes: Commander, Executive Director, Chief Enlisted Manager, Director of Operations, Air Force Food and Beverage Division Chief, Program Manager, Director of Strategic Marketing, and their spouses, family members (parents, children, siblings, and their respective spouses, regardless of where they live), and individuals living in the same households, whether related or not, of the above. AF Club membership is not free, and all new members will be assigned a monthly AF Club dues plan. By submitting information and creating an AF Club account, Entrants agree to the terms of use and privacy notice. If Entrants do not agree to such terms of use and privacy notice, they cannot become AF Club members or participate in this Sweepstakes. Each Entrant, by participating in the Sweepstakes, agrees to be bound by the Official Rules and the decisions of the Program Manager.

A. Two ways to enter:

1. Submit a paper copy of the AF Club Membership Application to your local Air Force Club during the Sweepstakes Period, as defined herein.

2. Go to [www.myairforcelifelife.com](http://www.myairforcelifelife.com) and apply for AF Club membership. Complete the application form, which may include but not be limited to the following required information: full name, mailing address, e-mail address, telephone number, and related information as prompted. Entrant must include all required information on the application form in order to be eligible for the Sweepstakes.

B. **Entry Limit and Disqualification:** Entrants are limited to one (1) entry per person for the entire Sweepstakes Period, as defined herein, regardless of their method of entry. Entries may only be submitted by a single Entrant (e.g. group entries not accepted). Entrant agrees to comply with the Sweepstakes Official Rules. Entries in excess of the entry limit stated herein or not in compliance with these Official Rules will be disqualified from the Sweepstakes. Decisions of the Program Manager are final and binding.

6. **PROHIBITIONS AND CONDITIONS OF ENTRY:** The use of any automated entry software or device is prohibited. Entries generated by a script, macro or other electronic, mechanical, or automated means are ineligible and will be disqualified. Illegible, incomplete, or inaccurate entries are void. By participating, Entrants agree to comply with these Official Rules, including all eligibility requirements. In the event of a dispute regarding the owner of an online entry, the online entry will be deemed to have been submitted by the authorized account holder from which the entry is made. Any attempt by an Entrant or any other individual to deliberately damage any online service or web site or undermine the legitimate operation of this Sweepstakes may be a violation of criminal and civil laws and should such an attempt be made, the Program Manager reserves the right to seek damages and/or other remedies from any such person to the fullest extent permitted by law. The Program Manager's failure to enforce any term of these Official Rules shall not constitute a waiver of that or any other provision. Neither Program Manager nor anyone acting on

its behalf will enter into any communications with any Entrant regarding this Sweepstakes, except as expressly set forth in these Official Rules.

7. **RANDOM DRAWING:** Random drawings will be conducted on the Sweepstakes Drawing Dates identified in item 2 of this document. During each drawing, a total of eight (8) prize winners from among all applications received, will win a prize. The random drawings will be conducted by the Air Force Services Activity (AFSVA) Directorate of Operations, Food & Beverage Division (SVOF) and AFSVA Directorate of Strategic Marketing (SVK). Decisions of AFSVA/SVOF and AFSVA/SVK will be final and binding on all matters relating to this Sweepstakes random drawing.

8. **PRIZES:** A total of eight (8) prizes total will be awarded. All Grand Prizes are each \$500.00 Best Buy e-gift cards and will be awarded as an e-gift card. E-gift cards may not be transferred, extended beyond the expiration date, or redeemed as cash. Please allow two (2) weeks after the announcement of the winners for the e-gift cards to be automatically e-mailed to the winners. C. **Additional conditions of prizes:** The prizes do not include any other incidentals not mentioned in these Official Rules. Any other incidentals or expenses not stated herein as part of the prizes are the winners' sole responsibility. 9. **NOTIFICATION AND VERIFICATION OF WINNERS:**

Winners will be notified by e-mail no later than two weeks after each weekly drawing.
